MOMS FOR LIBERTY UNION COUNTY PA CODE OF CONDUCT AND MEMBERSHIP PLEDGE

Goal: To establish a set of principles and practices for Moms for Liberty Union County members that will set parameters and provide guidance for member conduct and decision-making.

Code: Members of Moms for Liberty Union County are committed to observing and promoting the highest standards of ethical conduct in the performance of their responsibilities as members. Moms for Liberty Union County members pledge to accept this code as a minimum guideline for ethical conduct. Members shall:

ACCOUNTABILITY

- Faithfully abide by the By-laws and Policies of Moms for Liberty, Inc. and Moms for Liberty Union County
- Exercise reasonable care, good faith and due diligence in organizational affairs.
- Fully disclose, at the earliest opportunity, information that may result in a perceived or actual conflict of interest.
- Fully disclose, at the earliest opportunity, information of fact that would have significance in Moms for Liberty Union County leadership's decision making.
- Remain accountable for prudent fiscal management to chapter members, the board, and nonprofit sector, and where applicable, to government and funding bodies.
- Refrain from entering into a business agreement or contract on behalf of Moms for Liberty Union County.

EXCELLENCE

- Maintain a professional level of courtesy, respect, and objectivity.
- Assist other members in upholding this Code of Conduct.
- Strive to create a positive and enjoyable experience for yourself, fellow chapter members, and those you work with in the community.
- Be mindful of all communications (e.g. public speaking, emails, print pieces, websites, and social media), as an always-identifiable representative of Moms for Liberty Union County. All communications shall remain informational/encouraging (e.g. offensive jokes, cursing, yelling, and negative dialogue shall be avoided).
- Understand that the success of Moms for Liberty Union County depends upon volunteers in a variety of roles.
- Understand that Moms for Liberty Union County values its member volunteers and works to create resources and committees to support and enhance their involvement. However, volunteers conducting themselves in a manner inconsistent with the mission, or this Code of Conduct, may be removed.

PERSONAL GAIN

• Exercise the powers invested for the good of all members of the organization rather than for his or her personal benefit, or that of an outside group represented.

CONFIDENTIALITY

- Respect the confidentiality of sensitive information known due to membership involvement.
- Use significant effort to protect and maintain confidential information shared with the group for official business (e.g. constituent data).

MISSION STATEMENT:

We as the union County Chapter of Moms For Liberty are committed to holding our school directors, and administrators accountable through transparency and communication with the parents and community members of our district. We aim to restore in this district the once prominent Judeo-Christian values upon which this country was founded.

GOALS

- Transparency and Communication from our school district: administrators, board directors, faculty.
- Hold meetings between our chapter and school board directors so we work together to improve our school district. Communicate with and assist in resolving the issues facing our district.
- Develop a parental committee to review course curriculum, literature, resources, apps, policy, and handbooks.
- Provide information to our school directors of issues taking place within our schools, also assist with board policy and bylaws.
- Teach, understand, and follow our constitution.
- Prevent the implementation of Critical Race Theory or any of is related counterparts.
- Limit the involvement of the federal government in our schools, stand against mandates that strip parents of their rights, especially the right of freedom of choice.
- Limit the influence of special interest groups such as the PSBA, NEA, BLM.
- Goals of this chapter are subject to change as issues are resolved or new concerns present.

ALL MEMBERS:

I agree to adhere to bylaws, rules, and mission of the Union County Chapter, as well as those of the Nation Moms For Liberty Chapter/Oganization. I agree to this Union County Chapter Code of Conduct. I understand that my membership must be approved by majority vote of executive members, and can be revoked at any time by majority vote of executive members. I understand that voting rights are granted and or revoked by a majority vote of chapter executive members.

REGULAR MEMBERSHIP:

- Pay a yearly membership due of \$25.00. Dues renew every year in February, new members pay dues when approved. (\$5 goes to nation organization)
- I agree to attend at least 6 regular chapter meetings and at least 2 school board meetings through out the year.

ASSOCIATE MEMBERSHIP:

- Sign the Union County Chapter Code of Conduct.
- I am encouraged to attend at least 2 chapter meetings a year.
- I am NOT required to pay Memberhip dues.
