



Non-Disclosure Agreement (NDA) for Moms for Liberty Legislative Committee

This **Non-Disclosure Agreement (the "Agreement")** is entered into by and between:

Moms For Liberty, Inc. and **the undersigned individual** (the "Recipient"). This Agreement governs the behavior of the parties regarding a Moms for Liberty Legislative Committee (Committee).

The parties agree as follows:

1. Purpose

The Recipient, in connection with his or her participation in the Committee, will be exposed to and receive **Confidential Information** as defined herein. The purpose of this Agreement is to protect the confidentiality of this information.

2. Definition of Confidential Information

"Confidential Information" means all non-public information, data, or materials, in any format, provided by or on behalf of the Committee to the Recipient, or created by the Recipient during their Committee activities. This includes, but is not limited to:

- Discussions, deliberations, strategies, voting records, internal policy proposals, and legislative goals of the Committee.
- Draft or unreleased legislative documents, research, and lobbying plans.
- Non-public communications with Committee members, Moms For Liberty leadership, or outside consultants.
- Recordings of any Committee meetings, discussions, or other communications.
- Any information explicitly designated as confidential by the Committee.

Confidential Information does not include information that: (a) is or becomes publicly known through no fault of the Recipient; (b) was known to the Recipient prior to its disclosure by the Committee; (c) is disclosed to the Recipient by a third party with the legal right to do so; or (d) is independently developed by the Recipient without reference to the Confidential Information.

3. Non-Disclosure Obligation

The Recipient agrees to hold the Confidential Information in **strict confidence** and to take all reasonable steps to protect it from unauthorized disclosure.

The Recipient shall **not, without the prior written consent** of the Committee:

1. **Disclose, reveal, or communicate** any Confidential Information to any third party (including, but not limited to press, media, social media, political organizations or any other individual or entity outside of the Committee, **specifically including members of Moms for Liberty who are not part of the Legislative Committee.**
2. **Use** the Confidential Information for any purpose other than fulfilling the Recipient's duties as a member of the Committee.

The Recipient's obligation to maintain confidentiality **specifically applies to all discussions and deliberations that take place within the Committee** and requires that these remain within the confines of the Committee.

4. Term and Termination

The obligations of confidentiality under this Agreement shall **survive the termination** of the Recipient's involvement with the Committee and shall continue for a period of **(5) years** from the date of disclosure.

5. Remedies

The Recipient acknowledges that a breach of this Agreement may cause the Committee **irreparable harm** for which monetary damages alone may be an insufficient remedy. The Committee shall be entitled to seek equitable relief, including **injunction** and specific performance, in addition to any other remedies available at law.

6. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Florida.

Acceptance and Agreement

By signing below, the Recipient acknowledges that they have read, understood, and agree to be bound by the terms and conditions of this Non-Disclosure Agreement.
